

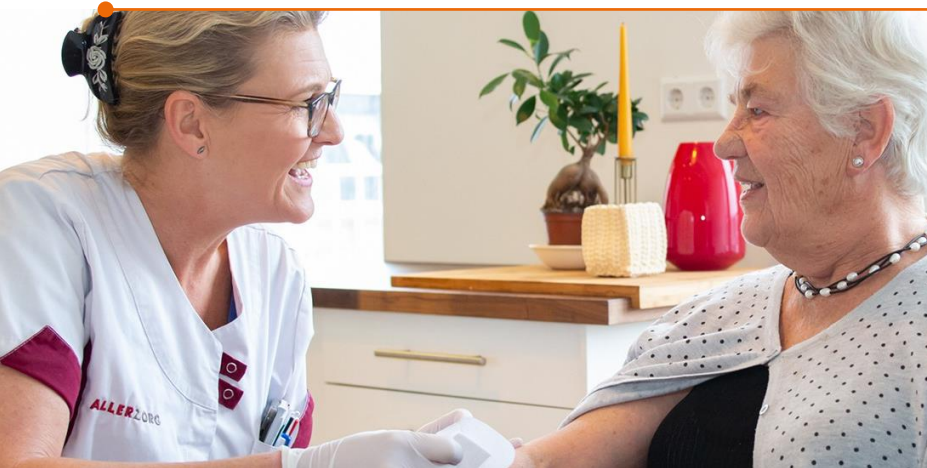

Per 31 maart 2021 is PGZ overgenomen door Allertzorg. Daarmee is PGZ, net als Allertzorg, onderdeel van Orpea Nederland. PGZ is gespecialiseerd in de begeleiding én behandeling van kinderen, jongeren en volwassenen met (een vorm van) autisme. Een team van professionals begeleidt en behandelt ruim 1.300 cliënten in de regio's Limburg en Noord-Brabant. Dit gebeurt thuis, op het werk, op school, op een PGZ-locatie of in één van de 18- of 18+ woongroepen. Ook mensen met andere psychische problemen kunnen bij de organisatie terecht.
